## Registered Veterinary Surgeons in Malawi


At its Annual General Meeting (AGM) in August, 2008, the Malawi Veterinary Association (MVA) noted with regret that there are a number of persons in the country masquerading as veterinary surgeons and who are in the process of illegally "practising" the veterinary profession.

This is an extremely dangerous development which is detrimental to the noble veterinary profession and a dangerous situation to both animals and society at large (public health) because these persons are not qualified to practice Veterinary Medicine in Malawi.

In view of this development, the MVA would like to advise the general public, livestock farmers and pet owners that the list below is that of qualified and registered veterinary surgeons and their location addresses. As such, it is only these persons who are legally allowed to practice Veterinary Medicine in the country.
